## SERICA ENERGY PLC ANNOUNCES INCREASE IN DIRECTOR'S HOLDINGS

**London, March 17, 2008** - Serica Energy plc (TSX Venture: SQZ; AIM: SQZ) ("Serica" or the "Company") was notified on 15 March 2008 that, on 14 March 2008, Paul Ellis (Chief Executive) increased his shareholding in the Company by 52,800 ordinary shares.

On 14 March 2008 52,800 ordinary shares were acquired at a price of CAD\$1.42 by Paul Ellis. As a result of this transaction the total beneficial shareholding of Paul Ellis has increased by 15.1% to 402,800 ordinary voting share capital of the company.

### Background Notes:

Serica Energy plc is an international oil and gas exploration company with operations in the UK, Norway, Spain, Ireland, Indonesia and Vietnam. It is currently developing a gas-condensate field in Indonesia (the Kambuna field) and appraising a gas-condensate discovery in the UK North Sea (the Columbus field).

The Company's ordinary shares are listed in London on AIM and on the Canadian TSX Venture Exchange under the symbol "SQZ".
